#### § 4 StipG Preclusion of Multiple Sponsorships

As per § 4 Abs. 2 StipG the Federal Ministry of Education and Research (BMBF) takes samples to avoid multiple sponsorships. For this purpose it may collect from a university the name, first name, date of birth, address and place of study of a person who is being awarded a scholarship according to the regulations of StipG.

The BMBF may record these data and align them with those of the *German Academic Exchange service*, the *Stiftung Begabtenförderung berufliche Bildung*, scholarship systems, and other national and international organizations. Universities are obligated to the transmission of data. After the implementation of a sample, data are to be destroyed.

#### § 13 StipG Statistics

As per § 13 StipG national statistics are being recorded on sponsorships according to the StipG. Annually the statistics record for the previous calendar year of each stipendiary the following characteristics covered: gender, nationality, type of intended degree, training school according to type and legal position, field of study, number of semesters, number of months sponsored and payments according to BAföG. As per § 14 Abs. 4 StipG there is an obligation to give information for the implementation of statistics. Obligated to give information are the universities. Due to those legal obligations the dissemination of your required data will take place without any separately given approval. By participating in the national scholarship program Deutschlandstipendium, you comply with the dissemination of your required data according to the preceding regulations.
